- Several suggested changes to the by-laws were presented. All Changes should be submitted to Rita for review. Paula will send suggestions to Rita
- Possible changes to the Application for the DDA were presented. Those changes would have to be presented to the city.
- We discussed possible events for Christmas if we weren't able to do the Iceskating rink. We would
  discuss it further in the event that the County wouldn't make a contribution to the DDA toward the
  purchase of the Iceskating Rink.
- Regarding the debris and tree removal on the Main street property(Wholesale property). Andrea suggested that we open it up once again for anyone that is willing to remove anything else can do so. A motion was made giving Andrea permission to move forward with the removal of debris from the Main street property by Lorraine Aguayo with a second by Paula McCain, motion carried.
- The City has agreed to do something regarding the Alleyway project. We need to give them a
  proposal and sample of what we are proposing.
- Andrea Spoke to DCA regarding Town hall meeting to possibly set up a lunch and learn.
- We agreed to compensate Brandon Roland for his assistance with the comedy show in the amount of \$175.00. Roy made a motion with a second by Lorraine, motion carried
- Revised the Facade Grant from 1,500.00 to 1,000.00 for and only issuing one application per quarter (4x annually). This can be revisited in 6 Months. A motion was made from the Facade Grant committee with a second by Paula McCain with a 6 month review, motion carried.
