- Paula McCain and Rita Llop presented skating rink rental agreements. Rita reminded the DDA that the DDA can't pay wages to employees outside of city limits, and suggested the renters may need to pay drivers separately. Loraine Aguayo said there are interested parties such as the Douglas Chick-Fil-A
- Paula McCain made a motion to accept bylaws presented by Rita Llop, with a second by Loraine Aguayo.
- Loraine Aguayo presented plans for the DDA website.
- Paula McCain updated everyone on the rural zone designation meeting. Rural zone is determined by historical buildings and initiatives by the city (façade grant, murals, pocket park)
- Andrea McCranie made a motion to move the July 1st meeting to June 24th at 6pm with a second by Paula McCain.
