The Leave It Better nonprofit organization requested a loan of \$10,000 to purchase blank bricks for the Pocket Park so they can complete that portion of the project. Upon receiving these funds the Leave It Better organization can then repay this interest free loan in full. A motion to move forward with the interest free loan was made by Wynnon with a Second by Paula and Lorraine. The motion passed.

## **New Business**

Andrea McCranie mentioned that she will be attending the meeting for SPLOST funds request being hosted by the County on Thursday, June 20<sup>th</sup>. She asked that each member of the Authority compile a list of potential projects to present to the Board of Commissioners and share this information with her by Thursday.

Following a Motion by Paula McCain and Second by Sammy Young a Façade Grant Application was approved for Mark Doss in the amount of \$1,500.00.

There was no formal Financial Report available but a verbal report was given. Chair McCranie will provide a P&L format for Mrs. Nash to use as the guide for future Financial Reports.

A motion was made by Wynnon Pittman with a Second by Sammy Young for the DDA to host a Comedy Show on September 7<sup>th</sup>, 2024 at the Magnolia Theatre. The cost will be no less than \$25.00 and no more than \$100.00 and Comedial Dale Jones will be the entertainment for the event. The Peacock House has agreed to donate a accommodations for the evening for Mr. Jones. There are developing plans for preshow and postshow parties with details for be released soon. The cost of the Comedian is \$2000.

A motion was made by Wynnon Pittman with a Second by Sammy Young for the DDA to host a 50/50 Raffle at the July 4<sup>th</sup> Fireworks event . The Chamber of Commerce will be handling the Americana accessories. Donny Screw and the Georgia Chryslers, will be performing and the County has agreed to sponsor the Performance. There will be food trucks in attendance at the event.
