Section 143 - Newly annexed areas in "Article XIV. Zoning Changes and Ordinance and Resolution Amendments" in Appendix A Zoning

**BE IT ORDAINED** by the City Council of the City of Eastman, pursuant to the authority vested in that body under the laws of the State of Georgia that:

The Code of Ordinances of the City of Eastman are hereby amended as follows:

The purpose of this ordinance is to repeal: Section 143 - Newly annexed areas in

"Article XIV. Zoning Changes and Ordinance and Resolution Amendments" in Appendix

A Zoning, as it pertains to newly annexed areas and zoning classification.

WHEREAS, the City of Eastman is a municipality duly formed and existing pursuant to Georgia law and provides for self government without the necessity of action by the General Assembly; and

WHEREAS, the City of Eastman, Georgia, has the legislative power to adopt clearly reasonable ordinances, resolutions or regulations relating to its property, affairs and local government for which no provision has been made by general law, and which are not inconsistent with the Constitution of or any charter provision applicable thereto; and

WHEREAS, the Council of the City of Eastman has determined that the ordinance herein resolved is in the best interest of the City; and

WHEREAS, this ordinance was first submitted to the planning commission which has recommended its adoption (*Appendix A, Article XIV Sec. 141*;

WHEREAS, the governing authority of the City of Eastman has read and considered the proposed ordinance; WHEREAS, notice of a public hearing was published in The Dodge County News on for a hearing on and said public hearing was held on that date: WHEREAS, Section 2.22 of City Charter of the City of Eastman provides initial introduction of such an ordinance prior to adoption at the regular meeting of the Council; and NOW THEREFORE, BE IT RESOLVED AND ORDAINED by the Council of the City of Eastman that this ordinance shall be maintained for public inspection at the Eastman City Hall under the custody of the City Clerk; NOW THEREFORE, BE IT RESOLVED AND ORDAINED by the City Council that Sec. 143 in Appendix A Zoning, in Article XIV.-Zoning Changes and Ordinance and Resolution Amendments, be repealed in its entirety and replaced with the following: All territory which may hereafter be annexed to the City of Eastman shall be classified in the R-1 Single-Family Residential District until otherwise classified by ordinance or unless a different classification is called for in the annexation ordinance. BE IT FURTHER ORDAINED that should any portion of this ordinance be declared unconstitutional, the remaining portions thereof shall not be affected thereby and shall remain in full force and effect. It is the intention of the City Council and it is hereby enacted that the provisions of this ordinance shall become and be made a part of the Code of Ordinances for the City of Eastman.
