## **PACKAGE STORE APPLICATIONS:**

**COUNCILOR PITTMAN:** Our first item under new business is package store applications. We have had discussion on them for the last 30 minutes. Pros, cons, and all. At this particular time, we will start with application 1, LDC Spirits and Wine, LLC.

**CITY MANAGER BARRON:** This will be the 214 Main Street. And the name on the application is Mr. Max Lanci.

**COUNCILOR PITTMAN:** Everything is in order? Meets state requirements and guidelines?

**CITY MANAGER BARRON:** We are 90% there.

**COUNCILOR PITTMAN:** Council, at this particular time I will entertain a motion to approve said application

for LDC Spirits and Wine, LLC. COUNCILOR MULLIS: So moved.

**COUNCILOR PITTMAN:** Have a motion from Councilman Mullis. I need a second.

COUNCILOR WOODARD: Second.

CITY MANAGER BARRON: This is the one that the City Building Inspector, Chief of Police, the City Manager, the Fire Chief, and the City Attorney all believe would violate state statute based on proximity to the South Dodge Primary School. 1078 McRae Highway.

**COUNCILOR PITTMAN:** And y'all had all of the measurements? Alright, in this case, since this one does not meet state statutes, it basically, at this point, can't go any further because it doesn't meet them. I will entertain a motion at this time to deny this application for SLM Management.

**COUNCILOR MULLIS:** So moved.

COUNCILOR HAMILTON: Second.

COUNCILOR PITTMAN: Have a second from Councilman Hamilton. All in favor show of hands. Motion

# **VEHICLE PURCHASE FOR WATER DEPARTMENT:**

**COUNCILOR PITTMAN:** Next item on the agenda is vehicle purchase for the water department.

CITY MANAGER BARRON: Yes, Sir, our water department has two vehicles in the shop right now. We are actually in a pretty bit of a desperate situation. But they have gone out and found a 2012 Ford F550 at Goodman Auto Sales. The water department, Mr. Raymond, Jack, you have gone and checked it out. They believe it is a good truck and believe it will give us a good number of years. They are asking \$18,417 to purchase it. The money is available in our SPLOST account. And I would ask that Council would consider letting us waive our bid process and let us purchase that truck, due to circumstances.

COUNCILOR PITTMAN: All right. Council, do y'all have any questions concerning the truck? If not, I will entertain a motion to approve the purchase of the 2012 Ford F550 from Goodman Auto Sales.

**COUNCILOR MULLIS: So moved.** 

**COUNCILOR PITTMAN:** Have a motion from Councilman Mullis. I need a second.

**COUNCILOR HAMILTON: Second.** 

COUNCILOR PITTMAN: Have a second Councilman Hamilton. All in favor show of hands. Motion carried unanimous.
